

**FIRST AMENDMENT TO AGREEMENT FOR PROFESSIONAL SERVICE BY  
INDEPENDENT CONTRACTOR**

THIS FIRST AMENDMENT TO AGREEMENT FOR PROFESSIONAL SERVICES BY INDEPENDENT CONTRACTOR (“Amendment”) is made and effective as of the 7<sup>th</sup> day of March 2023 by and between the CITY OF BEAUMONT (“CITY”), and Rogers, Anderson, Malody & Scott, LLP (“CONTRACTOR”). In consideration of the mutual promises and purpose contained herein, the parties agree as follow:

**RECITALS**

This First Amendment is made with respect to the following facts and purpose that the parties agree are true and correct:

On June 3<sup>rd</sup>, 2020, CITY and CONTRACTOR entered into that certain agreement entitled “Agreement for Professional Services by Independent Contractor” for Independent Audit Services (“Agreement”).

CITY has requested a change in scope to the work under the Agreement for additional services.

**AMENDMENT**

The Agreement is hereby amended as follows:

**Section 1** of the Agreement is hereby amended to extend the Term of Agreement through June 30, 2024.

**Section 2** of the Agreement is hereby amended to include the following:

“Upon expiration or termination of this Agreement, Contractor agrees to provide necessary documents and data to successor contractor retained, in a timely manner. Contractor shall cooperate to the fullest extent with any successor contractor in order to accomplish a smooth and orderly transition.”

**Section 4.01** of the Agreement is hereby amended as follows: Per this First Amendment, Contractor shall be paid at the rates set forth in Proposal dated February 7, 2023 (“Exhibit A”) in an amount not to exceed Fifty-Five Thousand, Eight Hundred Dollars and Zero Cents (\$55,800.00) for the audit of fiscal year ending June 30, 2023. This amount does not include work to be performed under a Single Audit, which would be subject to a separate compensation for services to be rendered based on rates set forth in Proposal.

The recitals to this Amendment are deemed incorporated herein by this reference. All other terms of the Agreement not expressly amended by this Amendment shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereby have made and executed this Amendment to be effective as of the day and year first above-written.
