The significant transactions during the quarter were as follows:

• LAIF interest recorded on 4/14/2023 in the amount of \$322,571.43, in comparison to prior year 3rd quarter payment was \$55,981.40.

- Net income received for the quarter on the portfolio managed by Public Trust is \$714,981.11.
- Interest received for the quarter on the Wells Fargo Sweep account is \$558,408.84.
- Interest received for the quarter on the Bank of Hemet accounts is \$3,321.42.
- The PARS earnings for FY23 are \$175,481.32.

The March PARS report was not available at the last meeting; therefore, it has been included in the attachments to this report along with the 4th quarter reports.

The City's sweep account is at a level over the investment policy threshold. City staff have been working with the City Treasurer for investment options for these funds which include purchasing CDs and establishing an account with a Joint Powers Association (JPA) Local Government Investment Fund (LGIF) that will complement LAIF. These transactions will be completed by the end of this month.

The Finance and Audit Committee reviewed this report at the July 24, 2023, meeting.
