AGREEMENT OF REMOVAL, APPOINTMENT AND ACCEPTANCE, dated \_\_\_\_, 2023, (the "Agreement") by and among the City of Beaumont, a general law city (the "City"), the Beaumont Financing Authority, a joint powers authority duly organized and existing under and by virtue of the laws the State of California (the "Financing Authority"), the Beaumont Public Improvement Authority, a joint powers authority duly organized and existing under and by virtue of the laws the State of California (the "Public Improvement Authority"), City of Beaumont Community Facilities District No. 93-1, a community facilities district formed pursuant to the Mello-Roos Community Facilities Act of 1982 ("CFD No. 93-1"), City of Beaumont Community Facilities District No. 2016-1 (Fairway Canyon, a community facilities district formed pursuant to the Mello-Roos Community Facilities Act of 1982 ("CFD No. 2016-1"), City of Beaumont Community Facilities District No. 2016-2 (Sundance), a community facilities district formed pursuant to the Mello-Roos Community Facilities Act of 1982 ("CFD No. 2016-2"), City of Beaumont Community Facilities District No. 2016-3 (Sundance), a community facilities district formed pursuant to the Mello-Roos Community Facilities Act of 1982 ("CFD No. 2016-3"), City of Beaumont Community Facilities District No. 2016-4, a community facilities district formed pursuant to the Mello-Roos Community Facilities Act of 1982 ("CFD No. 2016-4"), City of Beaumont Community Facilities District No. 2019-1, a community facilities district formed pursuant to the Mello-Roos Community Facilities Act of 1982 ("CFD No. 2019-1" and, together with the Financing Authority, the Public Improvement Authority, CFD No. 93-1, CFD No. 2016-1, CFD No. 2016-2, CFD No. 2016-3 and CFD No. 2019-1, the "Issuers"), Wilmington Trust, National Association (the "Prior Trustee"), and Zions Bancorporation, National Association (the "Successor Trustee").

#### **RECITALS:**

**WHEREAS**, the Issuers have previously issued the series of bonds (the "Bonds") listed on Exhibit A hereto, currently outstanding under the governing documents listed on Exhibit B hereto (the "Indentures") between an Issuer and the Prior Trustee;

**WHEREAS**, the Indentures provide that the applicable Issuer may replace the Trustee thereunder:

**WHEREAS**, the Issuers desire to remove the Prior Trustee as trustee under the Indentures and to appoint the Successor Trustee to succeed the Prior Trustee in such capacities under the Indentures; and

**WHEREAS**, the Successor Trustee is willing to accept such appointment as Successor Trustee under the Indentures;

**NOW, THEREFORE**, the Issuers, Prior Trustee and Successor Trustee, for and in consideration of the premises of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, hereby consent and agree as follows:

# ARTICLE I THE PRIOR TRUSTEE

**SECTION 1.01** Prior Trustee is hereby removed as Trustee under the Indentures.

**SECTION 1.02** Prior Trustee hereby assigns, transfers, delivers and confirms to Successor Trustee all rights, titles and interests of Prior Trustee in and to the trusts (as described in the Indentures), and all duties and obligations of Prior Trustee under the Indentures. Prior Trustee shall execute and deliver such further documents, instruments, and certificates and shall do such other things as the Successor Trustee and Issuers may reasonably require as to more fully and certainly vest and confirm in Successor Trustee all the rights, titles and interests hereby assigned, transferred, delivered and confirmed to Successor Trustee. The documents and instruments to be transferred and assigned to the Successor Trustee by the Prior Trustee include, but are not limited to, those described in Exhibit B attached hereto and incorporated herein.

# ARTICLE II THE ISSUERS

**SECTION 2.01** The Issuers hereby represent that all conditions relating to the appointment of Zions Bancorporation, National Association as Successor Trustee under the applicable Indentures have been met by the Issuers, and the Issuers hereby appoint Successor trustee as Successor Trustee under the applicable Indentures with like effect as if originally named as Trustee.

# ARTICLE III THE SUCCESSOR TRUSTEE

**SECTION 3.01** Successor Trustee hereby represents and warrants to Prior Trustee and to the Issuers that Successor Trustee is qualified to act as Successor Trustee under the Indentures.

**SECTION 3.02** Successor Trustee hereby accepts its appointment as Successor Trustee under the Indentures and accepts the rights, titles, interests, duties and obligations of Prior Trustee under the Indentures, upon the terms and conditions set forth therein, with like effect as if originally named as Trustee.

**SECTION 3.03** References in the Indentures to designated office or other similar terms shall be deemed to refer to the designated office of Successor Trustee at \_\_\_\_\_\_\_, or any other office of Successor Trustee at which its corporate trust business shall be administered.

## ARTICLE IV MISCELLANEOUS

**SECTION 4.01** This Agreement and the removal, appointment and acceptance effected hereby shall be effective as of the opening of business on \_\_\_\_\_\_, 2023 (the "Effective Date"). The responsibilities of the Successor Trustee under the Indentures shall commence on the Effective Date, and the Successor Trustee shall assume no responsibility for any liability prior to the Effective Date.

**SECTION 4.02** This Agreement shall be governed by and construed in accordance with the laws of the State of California.

**SECTION 4.03** This Agreement may be executed in any number of counterparts each of which shall be original, but such counterparts shall together constitute but one and the same instrument.

**SECTION 4.04** The Prior Trustee shall deliver each of the following to the Successor Trustee on or before, the Effective Date:

- a. The registers relative to the current bondholders and outstanding Bonds;
- b. All unissued Bond certificates along with a copy of the original and any subsequent printer's certificates and, if the Bonds have been delivered in accordance with DTC FAST procedure, the original Bonds;
- c. A list of all assets and account balances for each trust account as of the Effective Date;

The Prior Trustee will transfer all monies or other property held by it for the Bonds to the Successor Trustee. Delivery and receipt of such funds shall be acknowledged by execution of a cross receipt in the form attached as Exhibit C, appropriately completed.
