The M&M Group has extensive knowledge of both fair and entertainment management. Since the 1980s, our company's foundation and core began by producing and managing small, medium, and large festival and fair events at the municipal, county, and state level.

One of the first festivals that we booked and produced was the City of Rancho Cucamonga Grape Harvest Festival. The M&M Group played a vital and major role in what it has become today. Like the Cherry Festival, the Grape Harvest Festival included vendors, carnival rides, Arts & Crafts exhibitors, eating contests, and of course procuring live entertainment. We have worked with many Districts Agricultural Associations throughout the years and understand the ins and outs of an event organized by a state entity. From contractual terms and conditions to punctuality and execution, we are experienced in partnering and gaining the trust of our Fair clients and providing them with the support needed to produce a flawless event. We have a deep understanding of the significant detail that must be put forth when producing such events and how proper execution determines the success of the event. Here is what the process looks like when producing a four-day event for a City Client:


Our team meets with the citys committee to identify the entertainment goals for the event. This includes the type of entertainment, the day-to-day schedule, any wish list Artists / entertainment from the committee and/or community, and the budget. Once these components are established, the M&M Group gathers a list of available National touring Artists / Acts starting with the wish list artists, and then all other available artists and their price for performance. Once we accumulate a realistic list of possible Artists, we discuss the list of Artists with Festival committee. After the discussion, headlining artists are selected to perform for the festival and formal offers are approved and sent by the M&M Group to the Artist agents. The Artists are also made aware and agree to utilizing Festival in-house production. Once we confirm and secure the headline artists for each day of the event, we begin discussing local talent and strolling entertainment to secure for the event. Once these acts are established, offers are made and the acts are secured for the event. We then gather all artists riders and contracts for review and redlines. The artists production riders are shared and discussed with the fair production manager, and production advance calls are then scheduled and executed to discuss important information such stage plots, load-in/sound checks, set length, and all other production elements. After

scheduling and performance details are confirmed, our team puts together a very thorough written advance schedule and distributes the document to every party. On the day of show, the M&M group staff will arrive on site 1-2 hours prior to production & artist load-in. This allows our team to walk the property and inspect the production equipment that will be loaded-in the day prior. Our team will be first and main contact for the production team and Artists/crew and will ensure the schedule is adhered to. Our team will oversee and support the production team and Artist's load-in and sound checks, and ultimately make certain that the show begins per schedule. Our team will remain on-site and in direct support for the Artists and production team until the conclusion of the event.
