I have asked Aloha Plumbing Heating & Air to provide services, Under Section 1689.13 of the California Civil Code, in order to induce Aloha Plumbing Heating & Air to provide these services: 1) Initiated negotiation and contract; 2) Executed this contract in connection with the making of emergency or immediate necessary repairs or services necessary for the immediate protection of persons or personal property detailed on this invoice; 3) Expressly acknowledge and waive the right to cancel this contract within three or seven business days, whichever applies. There is no warranty on drain calls i.e.; clogs, as it is impossible to know when a roots, foreign objects, feminine products, or any other obstruction can and or will enter after "clearing" a drain.

Payment Terms: Due upon receipt. An account maintenance fee of 1 1/2% of the outstanding balance per month (18% annual percentage rate) will be added to amounts not paid within 30 days of invoice date. A \$35.00 charge is added for all returned checks.
