

**FIRST AMENDMENT
TO PROFESSIONAL SERVICES AGREEMENT BETWEEN CITY OF BEAUMONT
AND ALBERT A. WEBB ASSOCIATES FOR PROFESSIONAL ENGINEERING
SERVICES FOR THE WASTEWATER TREATMENT PLANT IMPROVEMENTS
PROJECT (CIP WW-15)**

THIS FIRST AMENDMENT TO AGREEMENT FOR PROFESSIONAL SERVICES BY INDEPENDENT CONTRACTOR is made and effective as of the ___ day of May, 2024, by and between the CITY OF BEAUMONT, a general law city, (“CITY”) whose address is 550 E. 6th Street, Beaumont, California 92223 and ALBERT A. WEBB ASSOCIATES, a California corporation whose address is 3788 McCray Street #32, Riverside, CA 92506 (“CONTRACTOR”) in consideration of the mutual promises and purpose contained herein, the parties agree as follow:

1. RECITALS

This First Amendment is made with respect to the following facts and purpose that the parties agree are true and correct:

A. On June 20, 2023, the City and ALBERT A. WEBB ASSOCIATES, entered into that certain agreement entitled “Agreement for Professional Services by Independent Contractor” for Professional Engineering Services for the Wastewater Treatment Plant Site Improvements (“Agreement”).

B. City has requested a further change in scope to the work under the Agreement regarding additional design services for site and facility improvements and CONTRACTOR has requested that the scope of work should be increased as provided in the Proposals dated October 17, 2023, and March 5, 2024, copies of which are attached hereto as Exhibit “A” and Exhibit “B” and incorporated herein by this reference.

2. AMENDMENT

Section 2 of the Agreement is hereby amended to add to the Services those services identified in the Proposals attached hereto as Exhibit “A”.

Section 4.01 of the Agreement is hereby amended to increase the maximum compensation under the Agreement as follows: Under the Agreement, compensation was set at two hundred sixty-four thousand, six hundred eighty dollars (\$264,680). Per this First Amendment, compensation is increased by the maximum amount of forty-two thousand, seven hundred and six dollars (\$45,359) as provided in the Proposal attached hereto as Exhibit “A” resulting in total compensation under the Agreement not to exceed three hundred seven thousand, three hundred eighty-six dollars (\$310,039).

The recitals to this Amendment are deemed incorporated herein by this reference. All other terms of the Agreement not expressly amended by this Amendment shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereby have made and executed this First Amendment to Professional Services Agreement to be effective as of the day and year first above-written.
