AFTER ACTION REPORT JUNE 13 – JULY 25 2024



SUMMARY:

This event was sponsored by the City of Beaumont. June 13, 2024, was the first night of 7 market nights/concerts to make up Beaumont Nights @ Towncenter. The event was held on Thursdays from 5pm – 9pm. It was comprised of food and craft vendors, a kid's fun zone, and a live band. The event was held on Beaumont Ave., between 6th Street and 8th Street, and 7th Street from the alley way east of Beaumont Ave. and the alley way west of Beaumont Ave.

EVENT DUTIES:

- Police Department's primary duties were to provide safety at the event, as well as traffic control during the beginning and ending of the event. Sworn staff was comprised of overtime and regular time personnel (9 total). The intersections of 6th and Beaumont Ave. and 8th and Beaumont Ave. were staffed as vendors entered and exited the event.
- On June 12th, officers contacted each of the Alcohol Beverage Control (ABC) licensees in the Beaumont Nights area (Craft Lounge, La Martina, Players' Lounge and Tuscano's Pizza & Pasta). Each restaurant/bar conducted business as usual, with the exception of Craft Lounge. Craft Lounge set up according to their ABC approved "Covid-19 Temporary Catering Authorization" (license number 42-591190) permit.

STAFFING AND ATTENDANCE:

- Each week The Beaumont Nights drew approximately 1,500 2,000 visitors during the four-hour period. July 4th had a crowd of approximately 2,000 – 3,000 throughout the five-hour period (1600 – 2100 hours).
- 48 70 vendors showed up to participate each night.

RECOMMENDATIONS FOR FUTURE BEAUMONT NIGHTS:

- Based on the number of police related incidents, and the number of people in attendance, I recommend staffing the event with one supervisor and four to five officers. This should be evaluated each week and adjusted according to the band that may be scheduled and incidents from prior weeks.
- Establish an Ordinance addressing temporary no parking dates, times and towing procedures. The Ordinance would articulate a designated area for vehicle "drop zone" and the fee imposed for the registered owner to pick up their vehicle. The Ordinance would also establish a length of time the vehicle would be at the "drop zone" before it was towed to a tow facility.
- Establish a designated area behind the stage (7th Street), allowing EMS an area to park if their services are needed for someone at the event.
- Vendors took approximately 45 minutes to clear Beaumont Ave at the end of the event. The trailer used to pick up the barricades/signs was an enclosed box trailer with a dropdown gate. In the past, City personnel have collected barricades from the parade route along Beaumont Ave. using an open trailer. This allowed barricades to be placed inside the trailer from both sides and no obstruction of the dropdown trailer gate. The enclosed trailer greatly increased the time it took to collect the barricades, which delayed the opening of Beaumont Ave. The open trailer would possibly assist with opening Beaumont Ave. more quickly.
- The city purchased the Advanced Security Technologies (AST) barricades designed to stop commercial sized vehicles. It is recommended these specialized barricades be deployed at each event.
- Prior to the event ending at 9:00 pm, it was dark, and the streetlights did not provide sufficient lighting for the overall safety of the event. The streetlights are operated by photocells and cannot be manually activated. It is recommended that lighting is placed within the interior of the event. The battery-operated lighting that was

implemented next to a few poles was not sufficient for the overall safety of the event.
