SUBJECT: Notice of Completion for the City Hall Renovation Project (CIP CF-104)

Description Completion of the City Hall Renovation Project (CIP CF-104), located at 550 East Sixth Street (Project).

Background and Analysis:

The City Hall Renovation Project's scope of work included renovating a 3,234-squarefoot portion of the existing Beaumont City Hall, including:

- interior wall reconfigurations,
- finishes,
- · ceilings,
- lighting,
- casework,
- interior windows,
- fire sprinklers,

- alarm systems,
- complete bathroom remodels,
- new roof,
- roof-mounted HVAC units,
- skylights, and
- other exterior items.

On May 21, 2023, the City Council awarded a Public Works Agreement (PWA) to Dalke and Sons Construction, Inc. (Contractor) for \$2,498,483 and a contingency of \$209,549, for construction of CIP CF-104 City Hall Renovation project.

On October 17, 2023, the City Council approved a budget adjustment and additional contingency of \$175,000. On July 16, 2024, the City Council also approved a ratification of the City Manager's authority to approve contract change orders up to \$317,731.

Three (3) change orders totaling \$317,731 were approved to complete the project, for a revised total contract amount of \$2,816,214. All change orders were funded from the project contingency noted above. The project's final billing is expected to be \$140,810.69, which includes the final retention payment owed to Dalke and Sons Construction, Inc. This retention payment will be paid 35 days after filing the Notice of Completion with the County of Riverside.


The Contractor completed the Project's scope of work satisfactorily per plans and specifications, and a Notice of Completion (NOC) document has been provided (Attachment A).
