SUBJECT: Notice of Completion for the Citywide Traffic Signal Upgrades at First

Street and Beaumont Avenue

Description Notice of Completion (NOC) for the Citywide Traffic Signal Upgrades, located at the intersection of First Street and Beaumont Avenue (Project).

Background and Analysis:

The Citywide Traffic Signal Upgrades at First Street and Beaumont Avenue include the installation of two (2) east and westbound traffic signal poles, signal gear, street name signs, pedestrian posts, and related appurtenances. This traffic intersection is owned and maintained by the U.S. Department of Transportation (Caltrans) due to the arterial transportation corridor of SR-79.

On April 4, 2023, the City Council awarded a Public Works Agreement to Elector Belco Electric, Inc. (Contractor) in the amount of \$203,888 to complete the project scope of work. The City Council also authorized a ten percent (10%) contingency of \$20,388 for any unforeseeable construction cost for a total of \$224,276.

On June 4, 2024, the City Council approved and authorized additional project funding in the amount of \$15,000 for materials testing, new timing sheets, and purchase of additional Caltrans-requested components to fully complete the Project.

Three (3) Contractor change orders were approved to complete the Project, totaling \$21,649.84 for a revised contract amount of \$225,537.84. All change orders were funded from the Project contingency noted above. Final billing for the Project is expected to be \$11,276.89, which includes the final retention payment owed to Elecnor Belco Electric, Inc. This retention payment will be paid 35 days after filing the Notice of Completion with the County of Riverside.


The Contractor completed the Project's scope of work satisfactorily per plans and specifications, and a Notice of Completion document has been provided (Attachment A).
