**SUBJECT:** Public Hearing and Consideration of a Resolution for the Second

Amendment to the City's Fiscal Year 2025-2029 Capital Improvement

Plan

**Description** Approval of Resolution to amend the five-year FY 2025-2029 Capital Improvement Plan (CIP).

### **Background and Analysis:**

The City's Capital Improvement Plan (CIP) is a 5-year planning document which identifies the major capital improvement expenditures and gives a proposed sequence of implementing their design and construction. The CIP is reviewed, revised, and adopted annually to account for completed and newly identified projects. Occasionally, the CIP is amended within a given year to promote better use of the City's limited financial resources, focus priorities, update projects, and assist in the coordination of public and private development.

On June 4, 2024, City Council adopted Resolution No. 2024-15 "A Resolution of the City Council of the City of Beaumont Adopting a Five-Year Capital Improvement Plan for Fiscal Years 2025-2029." Government Code Section 66022 allows the City Council to periodically update the adopted CIP.

On August 20, 2024, City Council approved the first amendment to the five-year Capital Improvement Plan for fiscal years FY 2025-2029.

Staff is proposing to amend the CIP further by adding five new projects, revising eight project budgets, renaming two projects, and closing one CIP project.

#### **NEW PROJECTS**

**R25-12 Streetlight Energy Efficient Upgrade:** This project will be funded through the Energy Efficient Conservation Block Grant to upgrade Citywide streetlights with energy efficient LED lights.

**R26-04 Traffic Signal Installation at Future Location:** This project will install a new traffic signal at a future location within the City to help with traffic flow and safety in FY 26. The tentative location is Pennsylvania Avenue and Second Street.
