

Resolution 2024-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BEAUMONT, CALIFORNIA, RECITING THE FACT OF THE GENERAL MUNICIPAL ELECTION HELD IN SAID CITY ON NOVEMBER 5, 2024, DECLARING THE RESULT THEREOF AND SUCH OTHER MATTERS AS ARE PROVIDED BY LAW

WHEREAS, a General Municipal Election was held and conducted in the City of Beaumont, California, on Tuesday, November 5, 2024, as required by law; and

WHEREAS, pursuant to Resolution No. 2024-12, the election was consolidated with the statewide general election and the Riverside County Clerk canvassed the returns of said election and has certified the results to this City Council, and said results are received, attached and made a part hereof as “Exhibit A”; and

WHEREAS, notice of said election was duly and regularly given in time, form and manner as provided by law; and that in all respects said election was held and conducted and the votes cast thereat, received and canvassed and the returns made and declared in time, form and manner as required by the provisions of the Elections Code of the State of California.

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Beaumont as follows:

Section 1: There were voting precincts established for the purpose of holding said election consisting of the regular election precincts in said City as established for the holding of state and county elections.

Section 2: Said general municipal election was held for the purpose of electing the following officers of said City as required by laws relating to cities in the State of California, to wit:

Two (2) Members of the City Council for a term of four years,

Section 4: That the names of the persons voted for and tallied number of votes at said election for Member of the City Council are as follows:

David Fenn	9,826 votes cast
Jason L. Doyle	2,807 votes cast
Joe Mathews	4,799 votes cast
Julio Martinez III	12,673 votes cast
Jessica Hedlund	3,673 votes cast

That the number of votes given in each precinct and the number of votes given in that City to each of such persons above named for the office of City Council, for which said persons were candidates were as listed in Exhibit "A" attached.

Section 7: The City Council does declare and determine that by way of majority votes:

Julio Martinez III was elected as a Member of the City Council of the City of Beaumont for the full term of four years, and

David Fenn was elected as a Member of the City Council of the City of Beaumont for the full term of four years.

Section 8: The City Clerk shall enter on the records of the City Council of said City a statement of the result of said election showing:

- (1) The whole number of votes cast in the City,
- (2) The names of the persons voted for,
- (3) For what office each person was voted for,
- (4) The number of votes given at each precinct to each person, and
- (5) The number of votes given in the City to each person.

Section 9: The Deputy City Clerk shall immediately make and deliver to each of such persons so elected a Certificate of Election signed by the City Clerk and duly authenticated; that the City Clerk or deputized designee shall also administer to each person elected the Oath of Office prescribed in the State Constitution of the State of California and shall have them subscribe thereto and file the same in the office of the City Clerk. Whereupon, each and all of said persons so elected shall be inducted into the respective office to which they have been elected.

Section 10: The Deputy City Clerk shall certify to the passage and adoption of this Resolution; shall enter the same in the book of original Resolutions of said City; and shall make a minute of the passage and adoption thereof in the records of the proceedings of the City Council of said City, in the minutes of the meeting at which the same is passed and adopted.
