SUBJECT: Public Hearing and Consideration of a Resolution for the Third

Amendment to the City's Fiscal Year 2025-2029 Capital Improvement

Plan

Description Approval of Resolution to amend the five-year FY 2025-2029 Capital Improvement Plan (CIP).

Background and Analysis:

The City's Capital Improvement Plan (CIP) is a 5-year planning document which identifies the major capital improvement expenditures and gives a proposed sequence of implementing their design and construction. The CIP is reviewed, revised, and adopted annually to account for completed and newly identified projects. Occasionally, the CIP is amended within a given year to promote better use of the City's limited financial resources, focus priorities, update projects, and assist in the coordination of public and private development.

On June 4, 2024, City Council adopted Resolution No. 2024-15 "A Resolution of the City Council of the City of Beaumont Adopting a Five-Year Capital Improvement Plan for Fiscal Years 2025-2029." Government Code Section 66022 allows the City Council to periodically update the adopted CIP.

On August 20, 2024, City Council approved the first amendment to the five-year Capital Improvement Plan for fiscal years FY 2025-2029.

On October 15, 2024, City Council approved the second amendment to the five-year Capital Improvement Plan for fiscal years FY 2025-2029.

Staff is proposing to amend the CIP further by adding 5 new projects, revising three CIP budgets, closing three CIP projects, and changing one project name.

NEW PROJECTS

R25-13 Pennsylvania and First Street Traffic Signal Upgrade: This project will convert one southbound through lane to a combination, left turn and through lane. Additionally, the eastbound through lane will be widened to accommodate a second through lane to match the receiving lanes, pending a feasibility review.

R25-14 Potrero Bike Lane Upgrade: This project will restripe the road with new Class II bike lanes along Potrero Blvd, between Highland Springs Avenue and the westerly terminus of Potrero Blvd.

R25-15 Downtown Revitalization Feasibility Study: The Downtown Revitalization Plan was approved on September 17, 2024. This project will take the concepts from the approved plan and perform the necessary traffic studies, geotechnical studies, right-of-way analysis, drainage studies, and preliminary designs for roundabouts, landscaping, lighting, parking, and pedestrian routes. The project will also have significant public outreach and City Council engagement.

T25-04 Mobile CNG/RNG Compressor: This project will provide on-site fueling for transit buses. City staff is requesting to transfer funds from T-07 and T-15 projects to T25-04 Mobile CNG/RNG Compressor.

T25-05 Shop Storage Tanks: This project will provide a workbench tank package for oil waste to help improve operations at the vehicle maintenance facility. City staff is requesting to transfer funds from closing out T-07 Two EZ Rider II CNG Buses project.
