**A RESOLUTION OF THE CITY OF BEAUMONT
AUTHORIZING THE WAIVER OF THE MAJOR SPECIAL EVENT
PERMIT APPLICATIONS AND FEES FOR THE BEAUMONT-CHERRY
VALLEY RECREATION AND PARK DISTRICT**

WHEREAS, the Beaumont–Cherry Valley Recreation and Park District ("BCVRPD") is a nonprofit special district established to enhance recreational opportunities and infrastructure for the community; and

WHEREAS, BCVRPD organizes annual community events that promote cultural, social, and recreational enrichment for the residents of the City of Beaumont ("City"); and

WHEREAS, these events contribute to community engagement and align with the City’s goals of supporting local partnerships and fostering community-driven initiatives; and

WHEREAS, the City has historically supported these events by waiving fees for permits, plan reviews, and staff time required for event applications and processing; and

WHEREAS, the City recognizes that providing such support allows BCVRPD to allocate more resources toward enhancing the quality of its programs and events for the benefit of Beaumont residents; and

WHEREAS, this Resolution formalizes the City’s continued support of BCVRPD events through a Memorandum of Understanding ("MOU") for a term of three years, terminating on June 30, 2028, unless extended or terminated earlier by mutual agreement; and

WHEREAS, the MOU includes provisions for fee waivers for permits, plan reviews, and staff time, as well as monetary support to offset the costs of police personnel when deemed necessary for events.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BEAUMONT AS FOLLOWS:

1. **Authorization of Fee Waivers** The City shall provide fee waivers for permits, plan reviews, and staff time associated with events organized by BCVRPD, contingent upon the submission of a completed fee waiver form for each event.
2. **Monetary Support for Police Services** The City shall provide monetary donations to cover police personnel costs required for BCVRPD events, subject to prior approval and documentation of need.
3. **Term of Agreement** The fee waiver and monetary support provisions authorized by this Resolution shall remain in effect for a period of three years, terminating on June 30, 2028, unless extended or terminated earlier by mutual agreement.
4. **Execution of MOU** The Mayor and/or City Manager is hereby authorized to execute the

Memorandum of Understanding between the City and BCVRPD on behalf of the City of
Beaumont.

5. **Effective Date** This Resolution shall take effect immediately upon its adoption.
