SUBJECT: Improvement Agreement and Security

Description Improvement Agreement and Security for Sewer, Street, and Storm Drain Improvements for Parcel Map 38953, Tract 31462-17, Tract 31462-19, Tract 31462-27, Tract 31462-28, and Tract 31462-29.

Background and Analysis:

The City requires all developers to provide security for public improvements consisting of, but not limited to, sewer, street, storm drain, utility, and survey monuments per City of Beaumont Municipal Code 16.56.010.




Figure 1- Vicinity Map

On August 20, 2024, City Council approved Tentative Parcel Map No. 38953 (PM2024-0003) subject to the Development Agreement and conditions of approval. Refer to Figure 1, Vicinity Map, for Project Location.




Figure 2- Parcel Map Layout

Tentative Parcel Map No. 38953 proposes to subdivide 110.19 acres into six (6) lots, as shown in Figure 2 – Parcel Map Layout.
