## FIRST AMENDMENT

TO PROFESSIONAL SERVICES AGREEMENT BETWEEN CITY OF BEAUMONT AND ALBERT A. WEBB ASSOCIATES FOR PROFESSIONAL ENGINEERING AND DESIGN SERVICES FOR THE BEAUMONT MESA LIFT STATION AND FORCE MAIN PROJECT (CIP WW-04 & WW-05)

THIS FIRST AMENDMENT TO AGREEMENT FOR PROFESSIONAL SERVICES BY INDEPENDENT CONTRACTOR is made and effective as of the \_\_\_ day of \_December\_, 2022, by and between the CITY OF BEAUMONT, a general law city, ("CITY") whose address is 550 E. 6th Street, Beaumont, California 92223 and ALBERT A. WEBB ASSOCIATES, a California corporation whose address is 3788 McCray Street #32, Riverside, CA 92506 ("CONTRACTOR") in consideration of the mutual promises and purpose contained herein, the parties agree as follow:

## 1. RECITALS

This First Amendment is made with respect to the following facts and purpose that the parties agree are true and correct:

- A. On February 15, 2022, the City and <u>ALBERT A. WEBB ASSOCIATES</u>, entered into that certain agreement entitled "Agreement for Professional Services by Independent Contractor" for <u>ENGINEERING AND DESIGN SERVICES FOR THE BEAUMONT MESA LIFT STATION AND FORCE MAIN PROJECT</u> ("Agreement").
- B. City has requested a further change in scope to the work under the Agreement regarding additional design services for existing deficiencies and CONTRACTOR has requested that the scope of work should be increased as provided in the Proposal dated November 3, 2022, a copy of which is attached hereto as Exhibit "A", and incorporated herein by this reference.

## 2. AMENDMENT

Section 2 of the Agreement is hereby amended to add to the Services those services identified in the Proposal attached hereto as Exhibit "A".

Section 4.01 of the Agreement is hereby amended to increase the maximum compensation under the Agreement as follows: Under the Agreement, compensation was set at five hundred thirty-six thousand, seven hundred eighty-five dollars (\$536,785). Per this First Amendment, compensation is increased by the maximum amount of fifty-six thousand, six hundred thirty-nine dollars (\$56,639) as provided in the Proposal attached hereto as Exhibit "A" resulting in total compensation under the Agreement not to exceed five hundred ninety-three thousand, four hundred twenty-four dollars (\$593,424).

The recitals to this Amendment are deemed incorporated herein by this reference. All other terms of the Agreement not expressly amended by this Amendment shall remain in full force and effect.

IN WITNESS WHEREOF, the parties hereby have made and executed this First Amendment to Professional Services Agreement to be effective as of the day and year first above-written.
