**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
BEAUMONT, CALIFORNIA, AUTHORIZING CERTAIN CITY  
OFFICIALS OF THE CITY OF BEAUMONT OR DESIGNEE TO  
ACCEPT THE FISCAL YEAR 2024 JUSTICE ASSISTANCE GRANT  
(JAG) PROGRAM AWARD IN THE AMOUNT OF ELEVEN  
THOUSAND ONE HUNDRED FORTY-TWO DOLLARS (\$11,142),  
AND TO AUTHORIZE EXECUTION OF ALL DOCUMENTS IN  
THE FURTHERANCE THEREOF**

WHEREAS, the City of Beaumont is eligible to receive Fiscal Year 2024 Justice Assistance Grant (JAG) Program funds in the amount of Twelve Thousand Three Hundred Eighty Dollars (\$12,380), administered by the County of Riverside as the designated fiscal agent; and

WHEREAS, the County of Riverside will retain ten percent (10%) of the City's allocation (\$1,238) for administrative costs, resulting in a net award to the City of Beaumont in the amount of Eleven Thousand One Hundred Forty-Two Dollars (\$11,142); and

WHEREAS, the City Council desires the City Manager, Deputy City Manager, and/or designee to accept the aforementioned grant and to execute, for and on behalf of the City of Beaumont, any document, including agreements, amendments, extensions, and grant award documents with the County of Riverside, or other responsible government agency, for the purpose of obtaining federal financial assistance provided by the Fiscal Year 2024 JAG Program.

**NOW, THEREFORE, BE IT RESOLVED,** The City Council hereby authorizes and does accept the Fiscal Year 2024 Justice Assistance Grant (JAG) Program Award in the amount of Eleven Thousand One Hundred Forty-Two Dollars (\$11,142).

**Section 1.** The City Council hereby authorizes the City Manager and/or designee to execute, for and on behalf of the City of Beaumont, a public entity established under the laws of the State of California, any actions necessary for the purpose of obtaining federal financial assistance provided by the U.S. Department of Justice and administered through the County of Riverside, including but not limited to signing agreements, amendments, and other related documents.

**Section 2.** The Resolution shall take effect immediately.
