

FIRST AMENDMENT TO AGREEMENT FOR INDEPENDENT CONTRACTOR

THIS FIRST AMENDMENT TO AGREEMENT OF SERVICES BY INDEPENDENT CONTRACTOR (“Amendment”) is made and effective as of the 5th day of March, 2024 by and between the CITY OF BEAUMONT (“CITY”), a general law city, and Omni Pro Inc., (hereinafter called “CONTRACTOR”) in consideration of the mutual promises and purpose contained herein, the parties agree as follow:

RECITALS

This Amendment is made with respect to the following facts and purpose that the parties agree are true and correct:

- A. On July 7th, 2023, CITY and CONTRACTOR entered into that certain agreement entitled “Agreement for Professional Service by Independent Contractor (“Agreement”) for Document Imaging and Quality Control Services.
- B. City has requested an extension of the term of the contract and compensation.

AMENDMENT

Section 1. of the Agreement is hereby amended to extend the term for an additional year; terminating July 7, 2025, unless extended by the parties with the approval of City Council.

Section 4. of the Agreement is hereby amended to increase the maximum compensation as follows: Under the current Agreement, compensation was set at a maximum not to exceed amount of Seventy Five Thousand Dollars and Zero Cents (\$75,000.00). Per this First Amendment, compensation is increased by an additional Two Hundred Fifty-five Thousand Dollars and Zero Cents (\$255,000.00) as provided in the Proposal attached here to as Exhibit “A” resulting in total compensation not to exceed Three Hundred and Thirty Thousand Dollars and Zero Cents (\$330,000.00).

The recitals to this Amendment are deemed incorporated herein by this reference. All other terms of the Agreement not expressly amended by this Amendment shall remain in full force and effect.
