NEGATIVE DECLARATION  
Cherry Channel Drainage Project**

In accordance with the California Environmental Quality Act (CEQA) and the CEQA Guidelines, City Staff prepared a Draft Initial Study/Mitigated Negative Declaration (IS/MND) that identifies and evaluates the environmental impacts of the Cherry Channel Drainage Project.

**Project Title:** Cherry Channel Drainage Project

**Project Location:** The Project site is located along Cherry Avenue, between Cougar Way and Oak Valley Pkwy.

**Project Description:** The City of Beaumont proposes replacing the turf geo-mat lining along an existing channel with concrete to improve flow conditions and reduce maintenance. The geo-mats have been damaged over time by urban runoff. The project will remove the existing geo-mat lining, wingwall, and riprap, replacing them with concrete along the slopes and channel bottom, while protecting the headwalls and culverts in place. This will reduce maintenance costs and improve runoff flow.
