10.04.010 Authority to enact certain regulations by resolution.

Under the provisions of Division 11 of the State of California Vehicle Code of 1959, as amended, the designation of "through highways," "Stop intersections," "speed zones," and the designation of parking lanes, parking zones, and crosswalks, and such other regulation of the flow of traffic as may be deemed necessary shall hereafter be enacted by resolution of the City Council.

10.04.020 Authority of City Engineer to Paint Curbs

- A.** The City Engineer is authorized, upon completion of an engineering and traffic study and field review documenting the need and purpose, to establish restricted stopping, standing, or parking zones on city streets.
- B.** Upon establishing any restricted zone under this chapter, the City Engineer shall post signs or cause curbs to be painted to provide notice of such restrictions and applicable hours of enforcement.

10.06.010 Curb colors.

The following curb colors shall only be used within the City, and the colors indicate as follows:

- A. Red indicates no stopping, standing or parking, whether the vehicle is attended or unattended, except that bus may stop in a red zone marked or signposted as a bus loading zone.
- B. Yellow indicates stopping only for the purpose of loading or unloading passengers or freight.
- C. White indicates stopping for either of the following purposes:
 - 1. Loading or unloading of passengers;
 - 2. Depositing mail in an adjacent mailbox.
- D. Green indicates time limit parking during the hours or times specified on signs posted therefor.
- E. Blue indicates parking limited exclusively to the vehicles of disabled persons and disabled veterans.

10.06.011 Changing Curb Colors

- A.** The City Engineer may designate specific curb marking colors (e.g., red for no stopping, yellow for loading, white for passenger loading)
- B.** The City Engineer shall officially designate the zone, including color, length, and applicable time restrictions.
- C.** Curb marking shall be implemented through painting and/or installation of traffic-control devices in compliance with Caltrans and City standards for pavement markings and signage.
- D.** No person or agency shall paint, mark, alter, or modify any curb or street surface—including curb numbering or colored zones—without prior express written authorization from the City Engineer or

designee. Any unauthorized painting is subject to removal/restoration and enforcement per applicable code.

E. The City Engineer or designee is responsible for regular inspections of curb markings to ensure compliance. Damaged, faded, or unauthorized markings will be repainted or removed at the expense of the party responsible. Penalties for violations shall be governed by Chapter 1.08.

F. This section does not prohibit property owners from painting curb numbers as part of an approved curb-addressing program, provided they secure prior written consent and comply with program guidelines

10.06.020 Penalty for violation.

In the discretion of the Enforcement Officer, any person violating the provisions of this Chapter 10.06 shall be issued an administrative citation pursuant to Beaumont Municipal Code Sections 1.17.200 et seq., or shall be guilty of an infraction pursuant to Beaumont Municipal Code Section 1.16.010. In either case, the amount of the fine shall be in the appropriate amount set forth in Section 1.16.030 of this Code. Each such violation shall be deemed a separate offense as specified in Beaumont Municipal Code Section 1.16.040.
