

RESOLUTION NO. 2025-

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF BEAUMONT, CALIFORNIA, ADOPTING A NEW PARKING VIOLATION AND LATE PAYMENT PENALTY SCHEDULE

WHEREAS, California Vehicle Code Section 40203.5 authorizes the City Council to establish a schedule of parking and late payment penalties and requires that, to the extent possible, such penalties be standardized within the county; and

WHEREAS, the City of Beaumont’s current parking and late penalty amounts are below those of surrounding jurisdictions and may not serve as an effective deterrent to unlawful parking behavior; and

WHEREAS, the City Council of the City of Beaumont finds that it is in the public interest to adopt a new parking and late penalty schedule that aligns with the regional average and promotes public safety and compliance with state and local parking regulations.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF BEAUMONT AS FOLLOWS:

SECTION 1. ADOPTION

The City Council hereby adopts the new Parking and Late Payment Penalty Schedule as shown in Exhibit A, attached and incorporated herein by this reference.

SECTION 2. EFFECTIVE DATE

This Resolution shall take effect 30 days after its adoption.

SECTION 3. REPLACEMENT

The new Parking and Late Payment Penalty Schedule shall rescind, supersede, and replace any previously adopted parking and late payment penalty schedules.

SECTION 4. AUTHORIZATION TO IMPLEMENT

City staff are authorized to take all necessary steps to implement the new Parking and Late Payment Penalty Schedule, including notifying the City’s citation processing agency and publishing the penalty amounts on the City’s website.

SECTION 5. CERTIFICATION

The City Clerk shall certify to the passage and adoption of this resolution and shall maintain it in the City’s permanent records.
