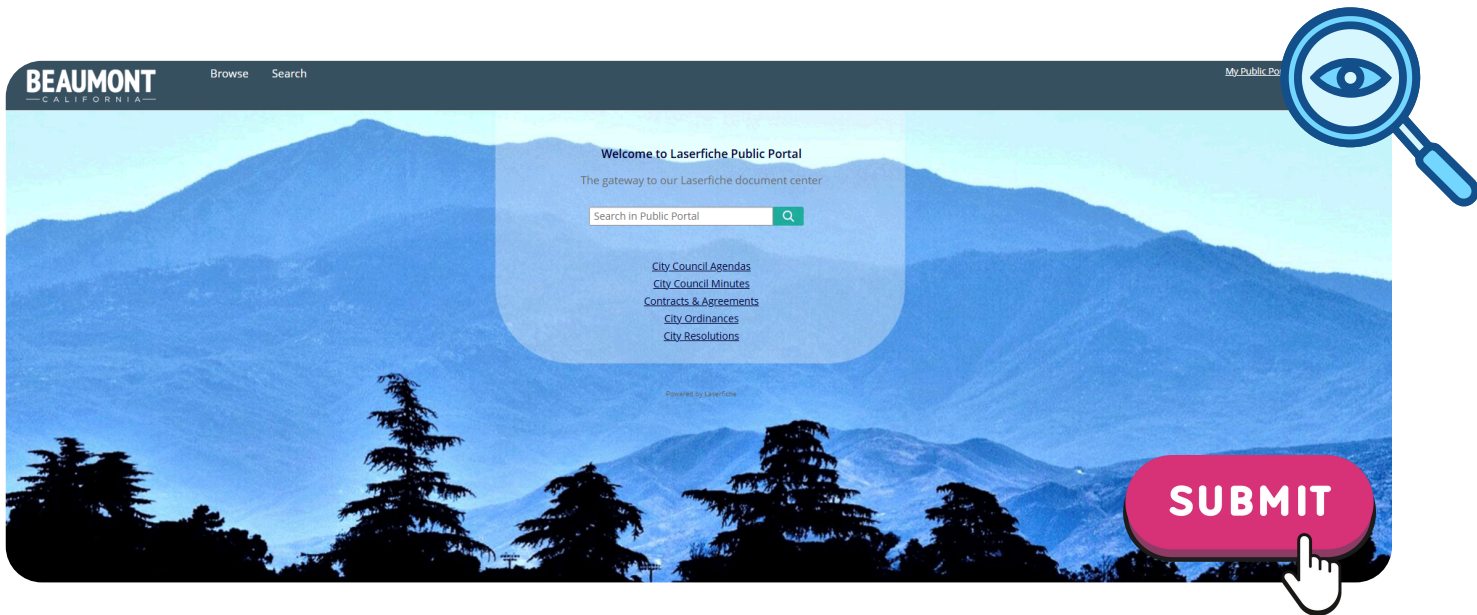

PROFESSIONAL DEVELOPMENT - ARMA CONFERENCE

In June, Records Technician Sabrina Glaze attended the ARMA Summer Conference, a professional development event focused on advancing records and information management practices. The conference provided training on the updated Information Governance Model and an informative perspective on AI implementation and its potential in a records setting, equipping staff with tools to enhance the City's records management program and support transparency and compliance efforts.

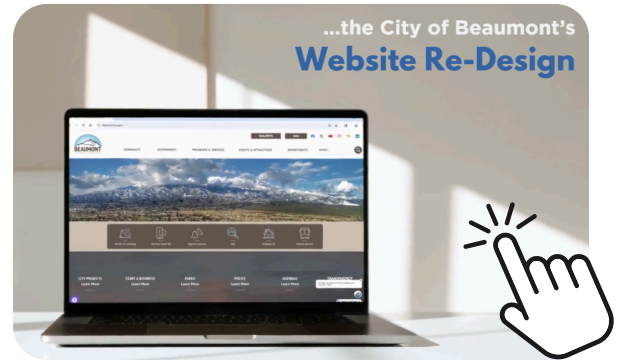

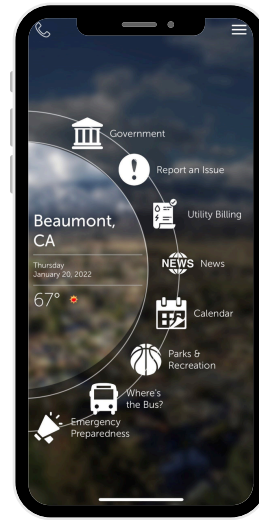

BUILDING & SAFETY

Staff consulted with the Finance Department to evaluate existing policies supporting full staff cost recovery in response to rising project-related expenses. The most recently adopted fee study incorporates Consumer Price Index (CPI) adjustments to ensure that fee revenues retain their value over time and that project applicants contribute their fair share toward service costs. Implementing fee increases in a transparent and consistent manner enables the City to keep revenues aligned with inflation, safeguard long-term financial stability, and avoid the need for significant or irregular budget adjustments.

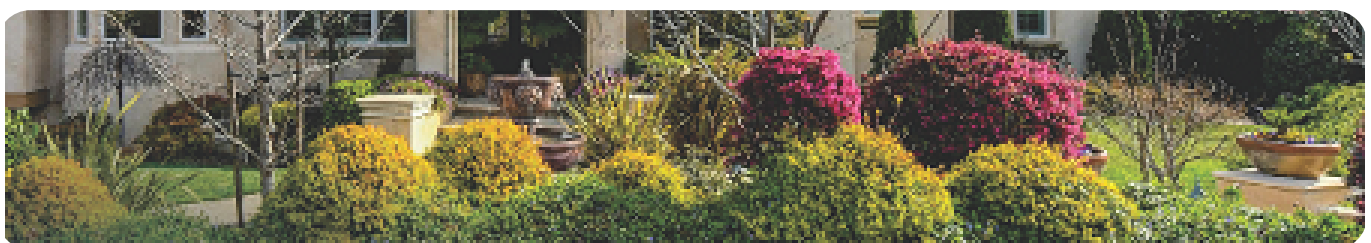

CODE ENFORCEMENT

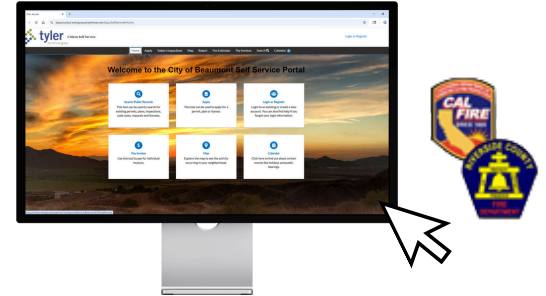
Weed abatement activities began in earnest during the late spring season with property inspections, noticing, and subscription service options to reduce fire hazards and protect public health. Requests for proposals (RFPs) were released and agreements were arranged to do work as-needed to protect lives and property by maintaining land and preventing vegetation from becoming a hazard.



COMMUNITY DEVELOPMENT

FIRE SERVICES

Required annual business inspections conducted by the Office of the Fire Marshal – essential for public safety, legal compliance, and operational readiness – can now be scheduled and tracked online through the City’s permit tracking system.



These inspections play a critical role in preventing fires, protecting lives and property, and enhancing overall community safety. By making the inspection process more transparent and accessible, the City supports greater community resilience and helps minimize disruptions to local commerce and daily activities caused by preventable fire and safety incidents.

PLANNING

Beaumont Regency

The Planning Commission approved and recommended adoption of an ordinance that authorizes the City to enter into an agreement by and between the City and Beaumont Regency AVG LLC for a 279,941 square-foot commercial shopping center for vested rights in exchange for certain community benefits, including infrastructure improvements.



COMMUNITY DEVELOPMENT

Beaumont Pointe



LAFCO approved the Beaumont Pointe project annexation to the city and concurrent annexation to the Beaumont-Cherry Valley Water District from Riverside County for the approximately 5 million square-foot industrial, commercial, and 125-room hotel project.

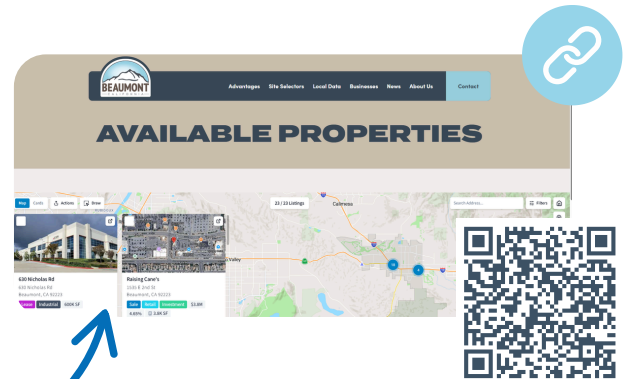

Pass Area Biz Hub

Three Pass Area Biz Hub lease agreements remain to be approved; two of these will be on the August 19 Council Agenda.

Internal building improvements are expected to be complete before the end of August, and partner agencies may begin moving in at that time.

The grand opening date will be announced in the coming weeks.



ECONOMIC DEVELOPMENT

Request for Proposal (RFP) Updates

Seven proposals were received in response to the RFP for an update to Beaumont’s Economic Development Strategic Plan. Internal review is complete. Subsequent review by volunteers from the Economic Development Committee is complete. The contract award is scheduled for September.

Six proposals were received in response to the RFP for Project and Construction Management for improvements at 105 E 6th Street. Review is expected to be completed in the first week of August.

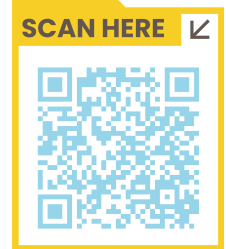

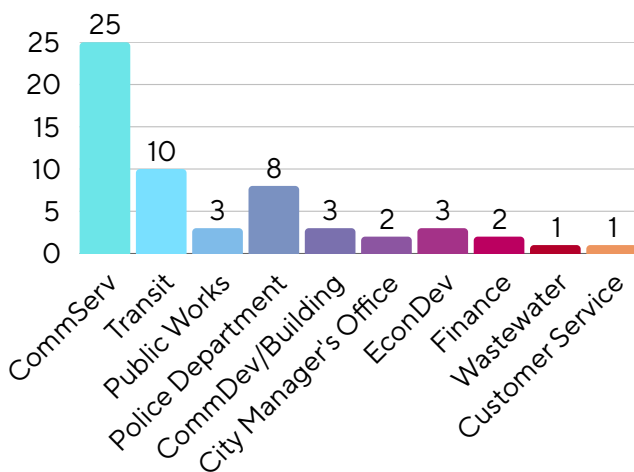

PLANTING AND RESTORATION



Playground wood chips (580 cubic yards) were installed across multiple city parks to maintain playground safety standards.



WCA successfully planted 101 new trees along Starlight Ave, contributing to the city's urban forest and shade equity.



Infield Stabilizer Mix (450 tons) was installed to city wide baseball fields.

NEW EQUIPMENT



New equipment was deployed for Grounds and Maintenance to improve their capacity for tree trimming, turf maintenance, and large-area fertilizer:

1 Bucket Truck, 1 Lily Broadcast Spreader, 1 Toro 60" Mower , and 1 Toro 72" Mower.

WEED ABATEMENT PROGRAM



This program officially started on July 28, managing weeds in high fire risk areas city-wide. Its scope covered approximately 975 acres and 90 individual property parcels.

Pop-Up in the Parks 🍌

Our summer pop-up event has expanded this year to include both morning and evening sessions to accommodate our working families. The morning session featured story time with the Beaumont Library’s Bookmobile, and the evening gatherings featured the usual games, art stations, and popsicles.

Two “Mega Pop-Ups” incorporated our Tech Time partnership with Riverside County and our Outdoor Walking Club, drawing diverse residents together in our local parks.

Red, White and Lights



We reimagined our traditional Independence Day celebration with a spectacular 22-minute drone show – one of the first locally to use overlapping drones for an extended performance.

The animations highlighted Beaumont icons, local sports, first responders, and classic 4th of July symbols. This special show took place alongside our ongoing Beaumont Nights market series, which has brought live concerts and 80–100 local vendors downtown every Thursday since April 17.

Milestones & Key Updates

California Transportation Commission (CTC) officially adopted the **Pennsylvania Avenue Grade Separation Project** for a potential award of \$50.4M.



A public scoping meeting was held for the **Oak Valley Parkway Interchange Project**, with positive feedback from the public.



The City Council adopted the Initial Study/Mitigated Negative Declaration (IS/MND) and Mitigated and Monitoring Report Program (MMRP) for the **Cherry Channel Drainage Project**.

The Notice of Determination (NOD) has been filed with the California State Clearinghouse (SCH) and Riverside County Clerk Recorder.

Vance Corporation was awarded the construction contract for the **Citywide Street Rehabilitation and Maintenance Project**.

Construction was completed on the **Beaumont Avenue Sidewalk Replacement Project**. Colored concrete sidewalks were added on the west side of Beaumont Avenue from 6th Street to 7th Street.

Second Street Extension Project is coming along ahead of schedule.

This month, the contractor poured the head and wing walls to the coverts that will funnel stormwater. These coverts will also act as structural support for the new road extension.



A **new Stop Sign** was installed at Desert Lawn Drive and Birdie Drive after a traffic study was performed.

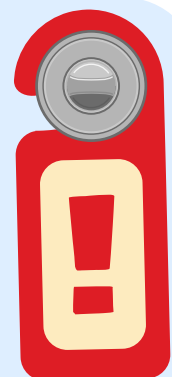
For the City to install a stop sign, the location must meet the warrants identified in the Manual for Uniform Traffic Control Devices (MUTCD).

The warrants are based on the volume, speed, collision history, and sight distances.



Construction for selected streets for the **Citywide Street Rehabilitation and Maintenance Project** will start mid-August. Check out the details and the [list](#) of streets.

Affected residents will be notified in advance by doorhanger notices at their residence, and No Parking signs will be posted along the street.

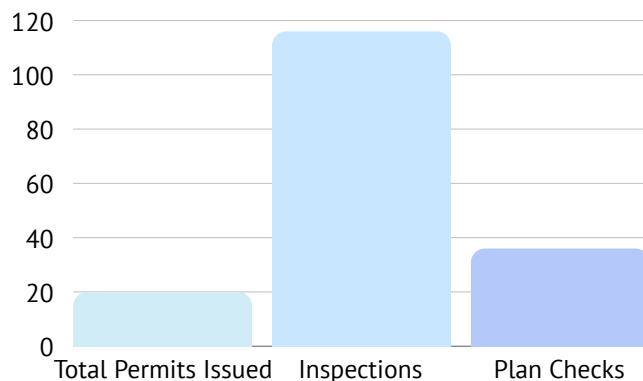

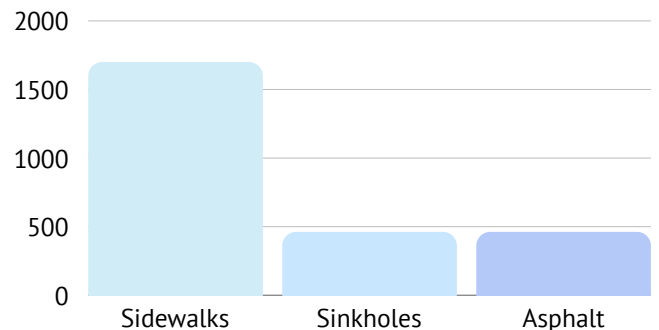

A time study is underway at the 6th Street and Highland Springs Avenue intersection to address the current inefficient timing at the signals.

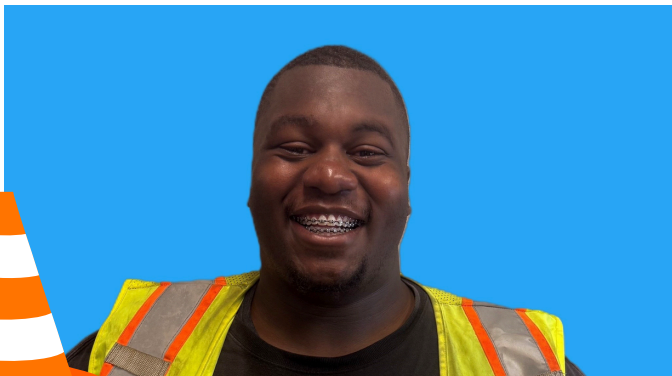
The Touch a Truck event allowed Public Works and Waste Management to interact with the public and share what we do.

YOUTH RIDE FREE

On July 1, we launched our “Youth Ride Free” program. Funded by a LCTOP grant, **youth can ride all routes on Beaumont Transit for free now through June 30, 2026.**

This program is being promoted on social media and will be featured during the Back to School Night with Beaumont Unified School District.

TRAVEL TRAINING

On July 15, Beaumont Transit staff accompanied and guided a group of 20 participants to Downtown Disney using public transit. In partnership with RCTC, our next excursion is on August 16 to LA’s Union Station.

Environmental Compliance began to review the **Fiscal Year 2026 Rate Increases for industrial users** in accordance with the City's adopted Rate Study.

Environmental Compliance met with **Perricone Juices, Tigre USA** and **Rudolph Foods** to address wastewater challenges.

Wastewater Collections and Environmental Compliance **addressed nuisance odor complaints** coming from residents in the Rangel Park - Historic Barrio Railroad District.

Environmental Compliance submitted the **yearly Area Search Report** to the Santa Ana Watershed Project Authority (SAWPA).

Environmental Compliance continues to **work with Rudolph Foods** on startup operations.

CJ Foods permit is set to expire on October 25, 2025 and a new permit is being drafted.

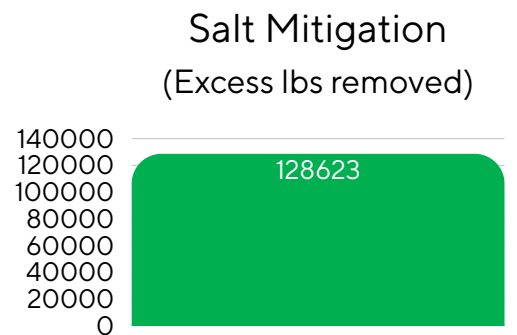
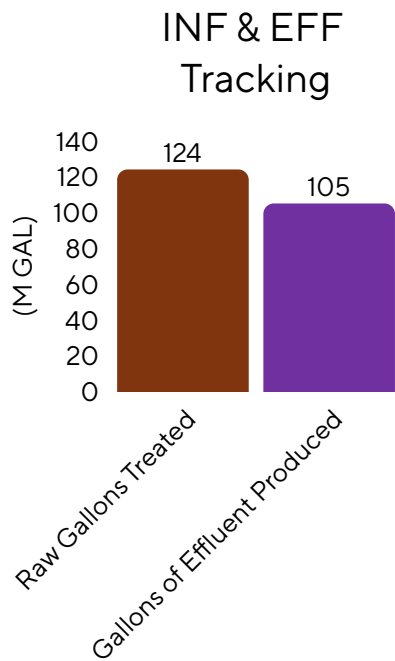
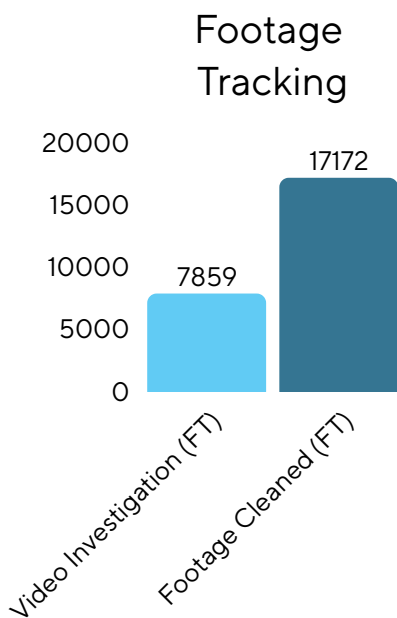
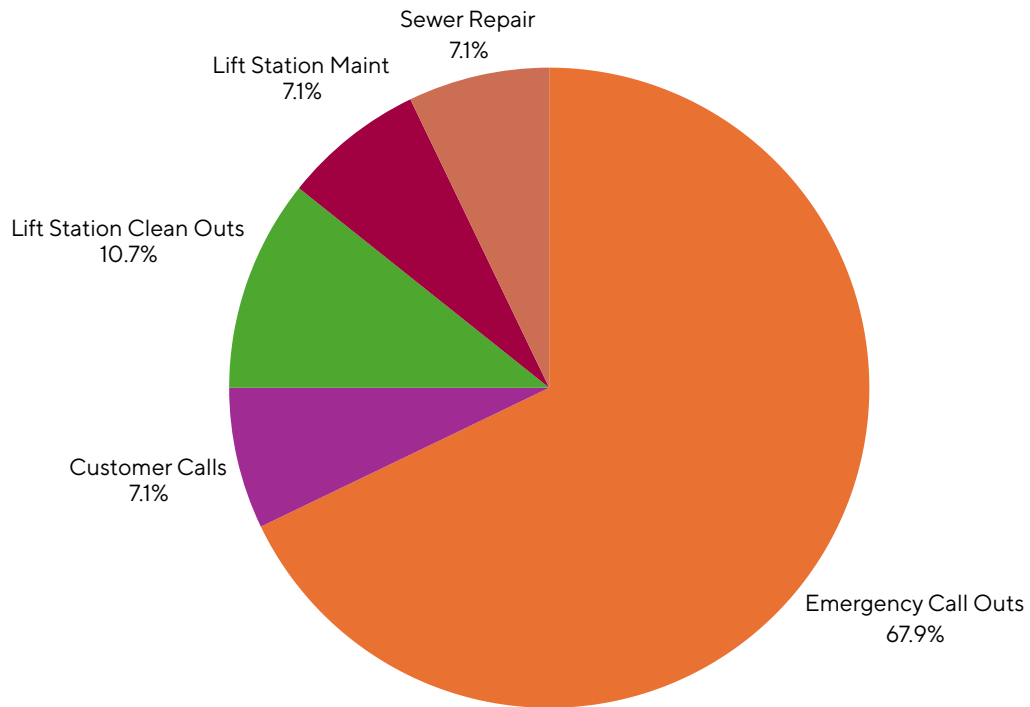
The City **completed construction of the 265,000 gal emergency storage basin** as a major part of the Mesa Lift Station Upgrade.

Design is approved for sewer improvements on Illinois Ave by the developer, National Core, as part of their 8th Street Apartments project. This will satisfy CIP WW26-02 when completed.
