

**AMENDMENT NO. 1 TO THE AGREEMENT FOR PROFESSIONAL SERVICES BY
INDEPENDENT CONTRACTOR**

THIS AMENDMENT NO. 1 TO AGREEMENT FOR PROFESSIONAL SERVICES BY INDEPENDENT CONTRACTOR (“Amendment No.1”) is made by and between the CITY OF BEAUMONT (“CITY”), a general law city, and Fehr & Peers, a California Corporation (hereinafter called “CONTRACTOR”) is effective as of this day: January 20, 2026.

RECITALS

This Amendment is made with respect to the following facts and purpose that the parties agree are true and correct:

- A. WHEREAS, on February 7, 2023, CITY and CONTRACTOR entered into that certain agreement entitled “Agreement for Professional Services by Independent Contractor (“Agreement”) to provide On-Call Traffic Engineering Services, as approved by City Council on February 7, 2023.
- B. City and Contractor now desire to amend the Agreement to extend the Term of the Agreement by two years, to February 7, 2028, and establish a not-to-exceed amount of Five Hundred Thousand Dollars (\$500,000) for services provided under this Amendment from January 20, 2026, through the remaining contract term.

The Parties therefore agree follows:

1. Amended Terms. The Agreement is hereby amended as follows:

- 1.1 The maximum compensation for the Services performed pursuant to this Amendment No. 1, from January 20, 2026, through the remaining contract term, shall not exceed Five Hundred Thousand Dollars (\$500,000) subject to the terms set forth in Section 4 of the Agreement.
- 1.2 The Term of the Agreement, as set forth in Section 1 of the Agreement, is hereby extended through February 7, 2028, unless sooner terminated or extended as provided in the Agreement.

2. Miscellaneous Provisions

- 2.1 Continued Effect of Agreement. The recitals to this Amendment are deemed incorporated herein by this reference. Except as amended by this Amendment No. 1, all provisions of the Agreement, shall remain unchanged and in full force and effect.

- 2.2 Consideration for Amendment. The parties hereby agree that they have each received adequate and independent consideration for the modifications to the Agreement set forth in this Amendment No. 1.
- 2.3 Counterparts. This Amendment No. 1 may be signed in any number of counterparts, each of which will be an original, but all of which together will constitute one instrument.
- 2.4 Electronic Signatures. Each Party may adopt as its signature an electronic identification consisting of a symbol or code that is affixed to or contained in each document transmitted by such Party (“electronic signature”). The Parties hereto hereby agree that electronic signatures are acceptable, shall have the same force and effect under the law as original wet signatures, and shall be sufficient to verify that the Parties have executed this Agreement and such other documents transmitted by the Parties.
