

**AMENDMENT NO. 2 TO THE AGREEMENT FOR PROFESSIONAL SERVICES BY
INDEPENDENT CONTRACTOR**

THIS AMENDMENT NO. 2 TO AGREEMENT FOR PROFESSIONAL SERVICES BY INDEPENDENT CONTRACTOR (“Amendment No.2”) is made by and between the CITY OF BEAUMONT (“CITY”), a general law city, and NV5, Inc., a California corporation (hereinafter called “CONTRACTOR”) is effective as of this day: January 20, 2026.

RECITALS

This Amendment is made with respect to the following facts and purpose that the parties agree are true and correct:

- A. WHEREAS, CITY and CONTRACTOR entered into that certain agreement entitled “Agreement for Professional Services by Independent Contractor (“Agreement”) to provide Plan Checking and Inspection Services, as approved by City Council on October 3, 2023.
- B. WHEREAS, CITY and CONTRACTOR executed Amendment No. 1, on June 17, 2025, to increase the annual not to exceed amount of Three Hundred and Sixty-Five Thousand Dollars (\$365,000) for the 2025 calendar year, returning to Two Hundred Fifteen Thousand Dollars (\$215,000) thereafter.
- C. WHEREAS, CITY and CONTRACTOR now desire to amend the Agreement to increase the annual not-to-exceed amount to Four Hundred Thousand Dollars (\$400,000) for services provided under this agreement. Services shall continue to be billed at the rates set forth in the proposal dated June 7, 2023, hereby provided as Exhibit A.

The Parties therefore agree follows:

- 1. Amended Terms. The Agreement is hereby amended as follows:
 - 1.1 The maximum compensation for the Services performed pursuant to this Amendment No. 2, shall not exceed an annual amount of Four Hundred Thousand Dollars (\$400,000), subject to the terms set forth in Section 4 of the Original Agreement.
- 2. Miscellaneous Provisions
 - 2.1 Continued Effect of Agreement. The recitals to this Amendment are deemed incorporated herein by this reference. Except as amended by this Amendment No. 2, all provisions of the Agreement, shall remain unchanged and in full force and effect.

- 2.2 Consideration for Amendment. The parties hereby agree that they have each received adequate and independent consideration for the modifications to the Agreement set forth in this Amendment No. 2.
- 2.3 Counterparts. This Amendment No. 2 may be signed in any number of counterparts, each of which will be an original, but all of which together will constitute one instrument.
- 2.4 Electronic Signatures. Each Party may adopt as its signature an electronic identification consisting of a symbol or code that is affixed to or contained in each document transmitted by such Party (“electronic signature”). The Parties hereto hereby agree that electronic signatures are acceptable, shall have the same force and effect under the law as original wet signatures, and shall be sufficient to verify that the Parties have executed this Agreement and such other documents transmitted by the Parties.
