**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF  
BEAUMONT, CALIFORNIA, ACTING IN ITS CAPACITY AS  
THE LEGISLATIVE BODY OF CITY OF BEAUMONT  
COMMUNITY FACILITIES DISTRICT NO. 2025-S (PUBLIC  
SERVICES) CERTIFYING ELECTION RESULTS**

**WHEREAS**, the City Council (the “City Council”) of the City of Beaumont called and duly held an election on December 16, 2025 within the boundaries of City of Beaumont Community Facilities District No. 2025-S (Public Services) (“Community Facilities District No. 2025-S” or the “District”) pursuant to Resolution No. \_\_\_\_\_ for the purpose of presenting to the qualified electors within the District Propositions A and B attached hereto as Exhibit A; and

**WHEREAS**, there has been presented to this City Council a certificate of the City Clerk canvassing the results of the election, a copy of which is attached hereto as Exhibit B;

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Beaumont, California:

SECTION 1. Each of the above recitals is true and correct.

SECTION 2. Propositions A and B presented to the qualified electors of the District on December 16, 2025 were approved by two-thirds or more of the votes cast at said election and Propositions A and B each has carried. The City Council, acting as the legislative body of the District, is hereby authorized to levy on the land within the District the special tax described in Proposition A for the purposes described therein.

SECTION 3. The City Clerk is hereby directed to record in the Assessor-County Clerk-Recorder’s office of the County of Riverside within fifteen days of the date hereof a notice of special tax lien with respect to the District which Bond Counsel to the District shall prepare in the form required by Streets and Highways Code Section 3114.5.

SECTION 4. This Resolution shall be effective upon its adoption.
